Compositions and Declamations are required throughout the College course. The Senior Class will declaim original compositions throughout the year.

The above course of instruction conforms essentially to that of the oldest and best Institutions of the country. In conducting the youthful mind over the field of Science, it is designed to bring all the faculties into exercise in the natural order of their development, and to preserve that proportion among them which will produce a proper *symmetry* and *balance* of character. Where some particular faculties, in the course of instruction, receive much more attention than others, it endangers an intellectual distortion, disqualifying the individuals for any but a particular calling. The object of Collegiate Instruction is not to *complete* either a practical or professional education; but, by discipline and cultivation, to bring out every power of the mind to its fullest and fairest proportions, and lay the foundation of a character fitted to appear with honor and usefulness in *any* department of society which Providence may call the individual to fill. Such an education will ordinarily lead to high intellectual attainments, and it is the best preparation for studying the learned professions, or entering the higher departments of business.

## TERMS OF ADMISSION.

1. On entering the College, the students are expected to present satisfactory testimonials of good moral character.
2. Candidates for admission into any of the advanced classes are required to furnish proper evidence of having completed all the preceding studies of the course.
3. No student will be enrolled, or admitted to the privileges of the College, until he shall have presented to the President, or some member of the Faculty, the Treasurer's receipt for his contingent fees.

## DIVISION OF THE YEAR.

The College Year contains three Terms of equal length. The Fall Term commences on the third Monday in August, and ends on the third Wednesday in November. The Winter Term commences on the third Monday in December, and ends on the third Wednesday in March. The Spring Term commences on the first Monday in April, and ends on the first Wednesday in July. The Commencement of the College is celebrated on the last day of the Spring Term.

## EXAMINATIONS.

The last three days of the Fall and Winter Sessions, respectively, will be devoted to an examination of the College Classes, in their studies for the Term. The last week of the Spring Term will be spent in an examination of the Students on the studies of the whole year.

## REMARKS.

As the Preparatory Course embraces four Terms, those who wish to pursue all the studies in this department, should enter in the Spring. The period assigned for this course will commence with the Spring Term of one year, and close with the Spring Term of the following year; so that Students may be prepared to pass regularly from this department into the Freshman Class, at the opening of the Fall Term.

## A NOTE TO PARENTS AND GUARDIANS.

Boys, fourteen years old, or younger, will be subject to the following regulations:—First, they will not be permitted to disburse their own funds, but will be required to have a Purser, who, if not designated by the Parent or Guardian of the Student, may be selected by the Faculty, or by the President of the Board of Trustees. Secondly, their *place of boarding* will be designated by the

Faculty. Thirdly, they will enter the department of the Institution judged by the Faculty best adapted to their ages, attainments and habits. Long experience has induced a conviction of the importance of each of these particulars. Without a strict adherence to them, there is but little prospect of this class of Students deriving much advantage from a connection with the College.

#### LIBRARY.

The College Library contains upwards of 8,000 volumes, well selected, among which are many rare and valuable works. Few institutions in this country possess one of equal extent and value. The importance of such a library to the reading Student, during his College course, is too obvious to need remark.

#### LITERARY SOCIETIES.

There are two Literary Societies in connection with the College. Each has a spacious hall devoted to it, fitted up in the most tasteful manner. They embrace nearly the whole body of Students. Such societies are of great utility to young men acquiring an education. They not only improve them in the art of public speaking, but also familiarize them, in some measure, with the forms of deliberative bodies, and cultivate systematic business habits. Each Society has a Library of its own.

#### PLAN OF ENDOWMENT.

ALLEGHENY COLLEGE is under the special patronage of the Pittsburgh and Erie Annual Conferences of the Methodist Episcopal Church, though under the immediate supervision and control of a Board of Trustees.

Any person subscribing and paying thirty-five dollars to the Centenary Fund Society, of either of the above named Conferences, secures a perpetual Scholarship in the College. The two Centenary Fund Societies are regularly incorporated; and through their Boards, elected annually by the Conferences, one having its seat in Pittsburgh, and the other in Meadville, they receive and invest the funds, collect and apply the proceeds. For the funds invested, security is taken on productive real estate to three times the amount loaned. The interest, when collected, is paid over to the College Treasurer, to defray the expenses of instruction. Thus, by a large, permanent and productive endowment, the salaries of the Professors may be paid, and tuition offered without charge.

#### EXPENSES.

Each Student is taxed \$2,00 per Term, to defray the current expenses of the College. These expenses are of various kinds, such as for fuel, services of

Janitor, printing, and the ordinary repairs of the College Buildings. The contingent fee must invariably be paid in advance.

#### BOARDING.

Board can be had in families at a price varying from \$1,75 to \$2,00 per week, including room, lodging, fuel and lights.

Those who associate and furnish their provisions, can procure their cooking done in families for about 25 cents per week. On this plan the whole expense is about 75 cents per week.

Damages done to the Public Buildings, by breaking lights, &c., when the person doing the injury cannot be ascertained, will be charged the body of Students, and the amount raised by assessment. Expenses of books, society fees, and pocket money, will vary according to the habits and circumstances of the Student. It is believed by the Faculty that much pocket money is not only unnecessary, but, in some cases, a serious injury to the Student at the College.

#### GENERAL REMARKS.

The Discipline of the College is mild, but strict. The Faculty endeavor to adopt such a course in the discharge of their official duties, in the College, that, while respect for order is preserved, every Student may feel that his teacher is his friend. Strongly convinced that the principles of morality and religion are essential to the happiness and prosperity of individuals and society—that no truly great or useful character can exist without them, they are frequently and earnestly inculcated. While entire freedom of religious sentiment and practice is allowed, the Students are required to attend regularly at some place of religious worship on the Sabbath, and on all occasions to treat the institutions of religion with respect.

Students who are religious are affectionately guarded, and their religious interests promoted by such means as are thought conducive to this end. Believing that the value of education very much depends upon the mental habits it forms, the Faculty endeavor to encourage and enforce, as far as they are able, the diligent and systematic employment of time.

Any books used in the course may be procured in the village at a reasonable price.

MEADVILLE, the seat of the College, is a beautiful country town, containing three thousand inhabitants. It is pleasantly located in the valley of French Creek, and for the health, industry, intelligence, and good morals of the community, will compare favorably with any other borough of similar size in the country. It is only thirty-seven miles from Erie, and is directly on the stage

route to Pittsburgh, and also on the route from Erie to Bellefonte. When the river is navigable, steam boats come up the Allegheny to Franklin, only twenty-four miles distant, and the canal furnishes a cheap and easy conveyance from Beaver and Erie. It is about ninety miles from Pittsburgh.

## Extracts from the By-Laws.

### ARTICLE I.

#### OF THE FACULTY.

"SECTION 1. It shall be the duty of every officer, individually, to use his utmost vigilance in carrying into complete effect the laws of the Institution. Each Professor being clothed with sufficient authority to make himself and the laws respected, he is to suffer no violation of them, known to him, to pass without due reprehension and punishment."

### ARTICLE III.

#### CONDUCT AND PERSONAL DEPARTMENT.

"SECTION 1. The Students of this Institution shall attend regularly and seasonably the public and private exercises, recitations, and lectures, established by the Faculty, or announced by the President, or by any of the Professors. They shall use their best diligence in preparing for the exercises assigned them, and shall perform them with all care and precision.

"SEC. 2. No Student shall attend the instruction of any one who may undertake to teach any language, science or art, in the town of Meadville, or its vicinity, unless such teacher be specially approved and authorized by the Trustees; provided, that the President of the College may give permission to attend upon an instructor, of merely the ornamental branches of Education.

"SEC. 3. Persons not intending to go through a full course of Collegiate Studies, will be admitted for the purpose of attending with the regular classes to such branches as they may wish to acquire.

"SEC. 5. Students are not permitted, in any case, to loiter about taverns, stores, or any other places of public resort.

"SEC. 6. Gambling, or games of chance, of every description, all profane and vulgar language, every species of irregular and immoral conduct, all scuffling and unnecessary noise, at any time or place, are strictly forbidden.

"SEC. 7. Habits of industry and economy are strongly recommended, and will be enforced among all the Students; and every one will be required to attend to all his duties with promptitude.

"SEC. 8. Any Student who shall be found to associate with low, vulgar or immoral company, or be addicted to habits of profaneness or dissipation, will, unless he immediately reform, be dismissed from College.

"SEC. 9. No Student shall be guilty of designedly injuring the character or feelings of any other Student.

"SEC. 10. No Student shall possess, or exhibit, any indecent picture; nor shall any one be allowed to purchase or to read any lascivious or immoral book while he continues a Student of this Institution.

"SEC. 11. No hallooing, loud talking, whistling, jumping, or other disturbing noise or act, shall be permitted at any time in the College Building; and any Student conducting himself disorderly in the town, or any other place, will be punished according to the nature of the offence.

"SEC. 12. No Student shall bring, or cause to be brought, gunpowder, fire-arms, or any deadly weapon, within the College premises; nor shall any one engage in any species of hunting during the College Term, without permission from the Faculty. No Student shall be allowed to smoke tobacco, in any form, within the College enclosure.

"SEC. 13. No student shall enter the room of another, or open a door, trunk, desk, or anything under lock and key, or otherwise secured, belonging to a Student, without permission.

"SEC. 14. No Student shall call a meeting of the Students without permission from the President.

"SEC. 15. Any member of this Institution who shall join, or countenance any combination whatever, that has a tendency to create opposition to the discipline of the Institution, either by making promise of secrecy, or otherwise, or who shall, by threats, or in any way deter others from the discharge of their duties, will be immediately dismissed; and shall never be re-admitted, without an express vote of the Faculty."

## ARTICLE IV.

### PUBLIC WORSHIP.

"SECTION 1. All the Students of this Institution shall be strictly required to attend public worship on Sabbath, at such places within the town of Meadville as they, their parents or guardians may select.

"SEC. 2. Any Student who shall conduct himself in a disorderly or irreverent

manner, at any place of religious worship, shall be suspended or dismissed, according to the circumstances of the case.

"SEC. 3. Prayers shall be attended every morning in the College, by the President, or some other member of the Faculty, at his request; at which time the Students are required to be present."

## ARTICLE V.

### PUNISHMENT.

"SECTION 1. In all cases where punishment may become necessary, the great object will be the prevention of misdemeanor, by reforming the pupil; and ultimately, when this is found impracticable, to remove him from the Institution.

"SEC. 2. The principal punishments will be private admonition, public reprimand, extra duties, confinement, suspension, private dismissal, and expulsion.

"SEC. 3. All the delinquencies and misdemeanors, not specified in the By-laws, shall be left to the judgment of the Faculty; and whenever, in the opinion of two-thirds of the Faculty, any Student is an injurious member of the Institution, by the use of profane language, the inculcation of irreligious principles, or the exercise of any influence tending to counteract the maintenance of good order, sound morals, and gentlemanly deportment, the Faculty shall have power, and it shall be their duty, when milder means have failed, privately to dismiss him from the College.

"SEC. 4. If any Student, when required by the Faculty, shall refuse to give evidence respecting the violation of any College law, or concerning any matter under consideration, shall falsify therein, he shall be punished by public confession, by admonition, or as the circumstances of the offence may require.

"SEC. 5. The President, or any of the officers, may require suitable assistance from any Student or Students, for the preservation of the good order of the College; and if any one so required shall refuse or neglect to give his assistance, it shall be viewed as a great contempt for the authority of the College, and shall be punished by public confession, suspension, or expulsion."

## ARTICLE VI.

### VACATIONS.

"SEC. 7. All who remain in the College, or its vicinity, in the times of vacation, shall be subject to the same laws requiring orderly conduct, as in the time of sessions.

"SEC. 8. No Student shall absent himself from the College without leave granted for some good reason, by some of the Faculty, nor shall he prolong his absence beyond the specified time."

## ARTICLE VII.

## REGULATIONS RELATING TO BOARDING.

"SEC. 1. All the members of the Institution, except those whose parents or guardians live in Meadville, or its vicinity, will board at such places as shall be approved by the Faculty, and shall be subject to such regulations as the Faculty may, from time to time, establish. At their boarding houses, and all other places, Students will be required to conduct themselves in conformity with the strictest rules of good breeding.

"SEC. 2. No Student shall be allowed to board at a tavern, or other house of public entertainment, without permission from the Faculty."

## ARTICLE IX.

## LITERARY SOCIETIES.

"SEC. 1. No Literary, or other Society, may be formed in either department of the Institution, without the consent of two-thirds of the Faculty.

"SEC. 2. If any Society should be found to interfere with the good order of the College, by shielding its members from discipline, or affording a cover for the violation of law, or in any other way counteracting good order, such Society may be restricted from its privileges, or may be dissolved by the Faculty.

"SEC. 3. The times and places of meetings of the Societies shall be at the discretion of the Faculty; and all meetings, whether of regular Societies, or of any other body of Students, shall be open to the attendance of the President or any other member of the Faculty.

"SEC. 4. If any Society of Students shall be dissolved, the books, apparatus and furniture, if any, shall become the property of the College, subject to order of the Trustees."
